UCHC PROVIDES PRIMARY MEDICAL SERVICES AT FIVE PRACTICE SITES IN ROSEBURG, GLIDE, AND MYRTLE CREEK, AND TWO SCHOOL-BASED HEALTH CENTERS AT ROSEBURG HIGH AND DOUGLAS HIGH IN WINSTON, OREGON, AND AN ACCESS POINT IN SUTHERLIN, OREGON. UCHC PROVIDES MEDICAL AND DENTAL SERVICES. ROSEBURG SERVES AS THE CENTRAL PRACTICE SITE, SUPPORTING ALL SITES. UCHC ALSO OFFERS THE ONLY SOURCE OF REDUCED FEE ORAL HEALTH SERVICES IN DOUGLAS COUNTY AT THE ROSEBURG SITE.
