Expenses: \$11,989.16

2) PASS Program (Parents for Academic Support Solutions)

This program seeks to work with North Portland's Somali immigrant community improve the high school graduation rate of Somali children. Expenses: \$11,781.93

3) North Portland Community Works (NPCW) and North Portland Neighborhood Services (NPNS)

Provides office support and staff assistance and acts as a fiscal sponsor for the eleven North and Northeast neighborhood associations. NPCW also provides insurance, banking, accounting and volunteer training for neighborhood projects. Expenses: \$19,770.17 (including insurance cost of \$11,411.00)

4) npGREENWAY (North Portland Greenway)

npGREENWAY envisions a 10 mile trail system providing access to and along the Willamette River enveloping the north riverfront from the Steel Bridge in downtown Portland to Cathedral Park near the St Johns Bridge and extending through Baltimore Woods to Kelley Point Park. The goal is to link North Portland neighborhoods with the Willamette River for recreation and access to jobs. Expenses: \$10,219.00
