Tournament and other designated programs and events to fund projects in keeping with our mission In December 2014 we partnered with Hermiston Morning Kiwanis Club and sponsored the Festival of Trees, raising over \$11,000 for the Foundation in this annual fundraiser The following statements indicate the grants and scholarships awarded during the 2014 fiscal year The organization's Form 990, Schedule I will only report what was actually paid out during the fiscal year Therefore, the following amounts may not reconcile with the Form 990, Schedule I reporting due to timing of post secondary school curriculums and grant need requirements In June 2015, we held our annual Scramble for Scholarships Golf Tournament and raised over \$19,000 specifically to fund students in the community seeking health care careers In May 2015, the Foundation awarded \$35,500 in scholarship funds to twenty-eight students One \$2,000 scholarship for nursing, one \$1,500 scholarship for nursing, one \$1,500 scholarship for medical infomatics, and one \$1,000 scholarship for medical options were given to GSHCS employees seeking advanced training Other scholarships include Two scholarships for \$1,000 to nursing students, one scholarship for \$2,000 to a nursing student, and one scholarship of \$1,000 for a medical options student, all attending Blue Mountain Community College One scholarship for \$500 was awarded to a student attending Eastern Oregon University in pediatrics One scholarship for \$500 to a biology/chemistry student, one scholarship for \$500 to a chiropractic student, and one scholarship for \$500 to a physical therapy student, each attending Oregon State University were given One scholarship of \$500 was awarded for a student attending Corban University in medical psychology One scholarship for \$1,000 was disbursed to an Arizona State University student in medical science One scholarship of \$1,800 for diagnostic imaging, one scholarship of \$1,800 for vascular technology, two scholarships for \$800 in diagnostic imaging and one scholarship of \$500 to a cardiology student were awarded to students attending Oregon Institute of Technology One scholarship of \$800 to a diagnostic imaging student attending Columbia Basin Community College was sent One scholarship to a University of Montana student in physical therapy for \$2,000 was awarded One scholarship to a student in nursing for \$1,000 at Lewis-Clark College was given One scholarship to a Boise State University student in medical lab services for \$1,000 was awarded A scholarship of \$2,000 to an Eastern Washington University student in physical therapy was disbursed One scholarship for \$500 to a medical lab science student attending Oregon Tech Watsonville was sent One scholarship to a Southwestern Oregon Community College student of \$2,000 for medical options was awarded One student from Walla Walla Community College received \$1,000 in nursing One scholarship for \$5,000 was awarded to a student of George Fox University in physical therapy Foundation grants are awarded twice a year in October and April Grants totaling \$133,570 were awarded this fiscal year as follows \$52,490 in grants were made to five designated charitable recipients including Eastern Oregon University, Blue Mountain Community College, Vange John Memorial Hospice, Domestic Violence West End Project, and Humane Society of Eastern Oregon from the interest on a bequest from Mary Ellen Paul Other grants made by the Health Foundation this fiscal year include \$2,000 Blue Mountain Community College for purchase of exercise equipment \$2,000 City of Heppner for water fountains and bicycle racks \$15,000 Domestic Violence Services to install security alarms and protection gates \$2,000 GSMC Education Department to purchase skin calipers and body composition analyzer \$5,000 GSMC Education Department to fund expanded health screenings and supplies \$4,500 Guardian Care Center to fund training for Child Abuse Protection team \$1,813 Stanfield Secondary School to purchase and install automated external defibrillators (AED) \$1,500 Umatilla County 4-H Leaders Association for counseling and training at-risk youth \$1,777 Umatilla-Morrow Headstart to purchase 50 infant car seats and boosters \$5,000 Altrusa International to fund the gateway to Oxbow Trail \$3,000 City of Irrigon for installation of security equipment at skate park facilities \$2,000 GSMC Education for Homemade Healthy Cooking weight loss and cooking program \$10,000 Echo School District PTA to fund replacement gravel at elementary school \$1,495 Good Samantan Ministries to purchase office equipment and software for counseling \$20,000 Hermiston School District to fund Kennison Field track commitment \$1,500 iCanBike for week-long training of children with disabilities \$1,895 Ione School District to purchase slide for community pool and water safety \$600 Stanfield Public Library to purchase Spanish medical collection and materials In December 2014, the Foundation again sponsored the "Christmas Spirit Award " This award solicited nominations from the community to identify
