Our purpose is to assist Oregon children, adolescents, young adults and families to develop a positive attitude toward themselves and others, to build self-esteem, accountability, and an appropriate degree of independence. We provide shelter and outreach services that address the issues of health, education, juvenile justice, life skills, and job-readiness, so as to reduce homelessness, runaway behavior, substance abuse, delinquency, family dysfunction, child abuse, delayed education, and unemployment.

Corvallis House, Overnight Shelter for youth ages 10-17

Most of the youth we serve in our overnight shelters need a place to stay for less than two weeks. They are provided a home-like environment, family-style meals, help with transportation to school and appointments, tutoring, and a variety of educational and enjoyable activities. Mediation with family, referrals for counseling or medical care, clothing and personal items are provided as needed. Most youth are able to reunite with their families with a new feeling of hope and a new knowledge of community resources to help them succeed long-term.

Some youth do not have a stable home to return to. Our goal is to allow these youth to stay as long as they need to, and to help them locate a new, healthy, permanent living situation. A case manager works with each of these youth to create an individual plan for stable housing and to help them learn the skills they will need as they transition to living independently.

After youth leave the shelter, they are contacted periodically by our After-Care Case Manager to keep them connected to any on-going services they might need.

For FY 14-15, 48 youth stayed at Corvallis House, for a total of 1,044 bednights

Outreach Services for youth & young adults, 10 to 24. This year we received a 3-yr renewable federal grant to expand this program. Many of our outreach services are intended to assist youth and families with the goal of preventing youth from becoming homeless or running away. These services are also available to young adults (up to age 24) who are too old to stay in our state-licensed shelters, but still need assistance as they work to achieve self-sufficiency.

Outreach clients have access to individual case-management and many of the same resources and activities that we offer to shelter residents, including tutoring, mentoring, peer-support groups, and Independent Living Skills Workshops. We also have a fast-growing "Street Outreach" program, designed to provide basic needs, information and referrals, and connections to community services for youth and young adults who are homeless or at risk of homelessness.

Other outreach services include: A 24-hour help line, offering crisis support, information, and referrals (590 callers last year); two Drop-in Centers; a new Rural Outreach program, taking our services to rural and small-town youth in their communities; and recreational and service-learning activities, using the Positive Youth Development model.

Last year nearly 1,400 youth throughout Linn & Benton Counties accessed one or more of our Outreach services

Albany House Overnight Shelter for youth ages 10 to 17: For several years we have worked to open a second overnight shelter in Albany, Oregon, and this year we did it! The new shelter has 10 beds, and the programs and services offered mirror those of our Corvallis House. The shelter will serve youth from Albany and from smaller towns and rural areas throughout Linn County.

During FY 14-15, we:

<> Worked with a donor who was willing to buy the house and lease it to us. The purchase was completed in July, 2014, and we began leasing the property in October 2014.

<> Worked with an architect, remodeling contractors, the Linn County Development Department, and our state licensing agency to make sure the building would suit our needs and comply with state and local regulations.

<> Obtained grants from the City of Albany for improvements to the building and from the Oregon Youth Development Council to hire staff for the start-up period.

<> Worked with community groups to help furnish the new shelter and build an inventory of linens, dishes, kitchen tools, clothing, grooming & hygiene items, bikes, games, and other supplies. The shelter opened on May 15, 2015.

Part II, line (1). Emily Dana, a founder and former Board Member, provided the loan for long-term operating support.

Part IV, line (1). In January of 2013, Carrie Thompson, along with her husband and three children, purchased a small house near a local high-school. (The legal entity making the purchase was a family-owned company, the East Fork Corporation.) To assist us in expanding services to older youth, the Thompsons rented the property to Jackson Street (for \$1/month) so that we could use it to house homeless youth ages 18 to 20, who had "aged out" of our emergency shelter for youth 10-17. On April 1, 2015, Jackson Street purchased the house from East Fork Corporation, who sold it for the same amount they had paid for it two years before, less a substantial discount given as a donation by the family. Carrie Thompson was elected to the Jackson Street Board of Directors on April 28, 2015.

Part IV, line (2). For several years, Jackson Street's Board and Executive Director had been working on a plan to add a second overnight shelter in Albany Oregon, but it proved difficult to find an appropriate building in a suitable location. In December, 2013, such a building was found, and it was for sale. One of our Board Members, Catherine Fisher (who is a realtor) stepped forward with a plan to secure the house without waiting until we could raise the funds needed to buy it through grants and donations. Catherine arranged for her father, Donald Fisher, to purchase the house, acting through his business, Klickitat Investments, LLC. The purchase was completed in July, 2014. In her capacity as a realtor, Catherine Fisher facilitated the sale and received a commission, which she donated to Jackson Street.

Since October, 2014, Jackson Street has been leasing the house from Klickitat Investments for \$1,100 per month. In January, 2015, we received a capital grant from the City of Albany that allowed us to put a \$35,000 "down-payment" on the house. The owner then used that money to finance the improvements and repairs required to turn the house into a youth shelter that could be licensed by the state of Oregon, and the shelter opened in May, 2015.

Over the next 2-3 years, Jackson Street will raise funds through grants and donations and will purchase the property from Klickitat Investments, LLC. It is our understanding that the purchase price will be the amount Klickitat paid in July 2014, plus the value of the 2015 improvements.

"Next Steps" Transitional Housing for Young Adults (Expenses = \$ 48,910) This program provides housing for youth ages 18, 19 and 20

who would otherwise be homeless. Once they turn 18, young people are legally classes as adults, but many 18-year-olds are still in high

school, and few are able to be completely self-supporting. This age group is still developing and needs support to transition into adulthood

The youth we serve in our Next Steps program have little or no support from parents or other family, and we provide secure housing for

these vulnerable youth while they complete secondary school (or obtain a GED) and prepare for higher education, vocational training, or

employment. Next Steps house has four beds and offers:

• Housing in a dorm/apartment-style setting

• Financial support for education, counseling, health care, and transportation

• Case management emphasizing the skills, resources, and community connections needed to live independently

• Skills training on topics such as relationships, health/fitness, communication, budgeting/savings, drugs and alcohol, and meal planning

• Coaching to help find and maintain quality employment

During FY 14-15, we completed a successful capital campaign and purchased Next Steps House. (See Schedule L for additional details.)
