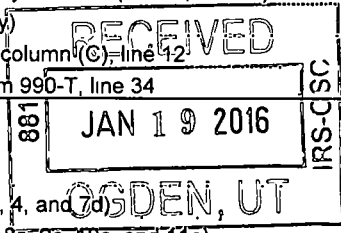

In addition, Mulberry School provides after school and before school day care for those individuals requiring such services and Mulberry School holds 8 weekly summer camp themed sessions for their students.
