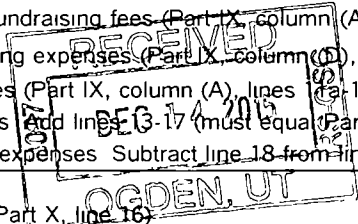

Artists-In-Schools:

The Artists-in-Schools program brings long-term performing arts experiences to youth in schools and child development centers. All of the Workshop's direct service programs aim to develop students' leadership skills, ability to make non-stereotypical choices in artistic work, ability to form healthy relationships with peers and adults, as well as their ability to focus and concentrate in a classroom setting. In particular, The Workshop's Artists-in-Schools program aims to improve students' pro-social behavior, ability to critique the artistic work of their peers, understanding and usage of artistic vocabulary, as well as their participation in group activities. The artist visits schools once per week for between 10-30 weeks, providing standards-aligned programming.

4b (Code) (Expenses \$ 256,981. including grants of \$) (Revenue \$)

Artists-In-Communities:

The Artists-in-Communities program offers tailored arts instruction to youth in after-school programs, community centers, juvenile halls, and county community/court schools. All of the Workshop's direct service programs aim to develop students' leadership skills, ability to make non-stereotypical choices in artistic work, ability to form healthy relationships with peers and adults, as well as their ability to focus and concentrate in a classroom setting. The specific goal of the Artists-in-Communities program is to work toward creative learning environments that foster self efficacy skills, cultural understanding, and engaging discussions around community and social issues. The artist visits Artists-in-Communities sites once or twice per week for between 10-30 weeks.

Advocacy:

At Performing Arts Workshop, we believe that arts programs are an essential part of each child's education. We also believe that the arts make youth more innovative, creative, and better critical thinkers - which are vitally important skills for the 21st Century.

As a result, school districts, local and state government need to be held accountable for providing instruction in the arts. In 2008, Performing Arts Workshop launched its advocacy initiative to achieve this broader goal - beyond the bounds of what the Organization's direct service can provide.
