They may, from time to time, compare the Executive Director's salary to that of Chief Public Defenders in other California counties and the District Attorney of the County of San Mateo. The Executive Committee then makes their recommendation to the entire 14 member Board of Directors of the San Mateo County Bar Association for final determination, the results of which would be recorded in the executive Session Minutes of the San Mateo County Bar Association. A written job performance evaluation, if prepared, would be included with the Executive Session Minutes. Anyone with a conflict of interest would be excused from the final deliberations. All other employees are hired at the discretion of the Executive Director.
