The Counseling Center, with its Individual and Group Counseling services for youth and the Reach Our Children (ROC) Medi-Cal Mental Health program, provides comprehensive wrap-around mental health services for children and youth. The center provides services for over 175 children, youth, and their families. The services are designed to ensure developmentally appropriate emotional and behavioral support.

4b (Code) (Expenses \$ 553,836 including grants of \$ 7,398) (Revenue \$ 11,502)

The Career Development and Prevention Center provides academic support, work readiness training, job placement, and on-the-job training opportunities for unemployed and underemployed youth and young adults ages 16-24. The Center works with 225 participants to provide them with basic skills, leadership development, and employment opportunities. The Environmental Training Center offers youth internship programs for 16 youth and young adults ages 14-24. Youth learn basic work ethics and standards, professionalism and skills necessary for further employment. Participants struggle with poverty and related chronic diseases such as high blood pressure, obesity, and diabetes. The Environmental Training Center's programs address these inequities by involving youth in paid internships to grow food and beautify urban areas.

4c (Code) (Expenses \$ 221,513 including grants of \$ 3,508) (Revenue \$ 7,247)

The Afterschool Center targets 75-100 children and youth, ages 6-14, who need additional support to improve their literacy and math skills. The center instructs participants in computers, arts & crafts, music instrumentation, sports and dance. Volunteer tutors from UC Berkeley and other local universities serve as important role models for the participants.
