Incorporated in 1973, Children's Council was among the first organizations in the country dedicated to helping parents connect to quality child care. Our programs currently touch the lives of more than 20,000 people each year. From its inception, Children's Council has been the hub of the local care landscape, working in partnership with the government funders, other community-based organizations, and child care providers to make affordable, high quality care a reality throughout San Francisco's diverse communities.

Children's Council supports families by administering child care subsidies on behalf of the state and city in San Francisco. Children's Council documents family eligibility and pays care providers based on timesheets submitted documenting hours of care. Monthly caseload averages 2909 children. Additionally, Children's Council manages the centralized eligibility database of families waiting for subsidies, matching children with subsidies as vouchers and subsidized slots become available, and facilitating placements. Through this service, approx 1,000 children accessed subsidized child care and early education in 2014-15.

Fiscal Intermediary - Fiscal Year 14/15 Children's Council was the Fiscal Intermediary for the Preschool for All program. Additionally, we are the fiscal intermediaries for three non-profits including the Child Care Planning Council (CPAC), the San Francisco Child Care Provider Association (SFCCPA), and the Family Child Care Provider Association (FCCPA). The SFCCPA worked to receive their own 501(c)3 status and is now independent starting July 2015.

Provider Services - Children's Council offers a variety of training, coaching, and consultation for child care providers. In 14/15, 229 Family child care centers (FCCs) received individualized coaching and training through our Family Child Care Quality Network. Our Health and Nutrition Department supported 285 FCCs in San Francisco and San Mateo counties through the USDA Child Care Food Program, providing financial reimbursement for serving more than 1,000,000 healthy meals and snacks to the 2,374 children in their care. 30 child care providers improved the nutrition and physical activity practices in their child care environments by participating in the "Healthy Apple" program, which included a self-assessment, information, training, and additional resources. Children's Council conducted 87 workshops and other educational opportunities in English, Spanish, and Cantonese for 1,056 participants. 160 hours of training were provided through our CLASS Plus training program, which included additional on-site coaching to 14 ECE providers. 83 ECE providers completed the CARES Plus program, including online training on CLASS and professional development advising.
