Ross Valley Players (RVP) presents a main season of six major productions performed between July and June of the following year For fiscal year 7/1/14 thru 6/30/15 there were 19 performances for each of Old Money, Fox on the Fairway, Persuasion, Impressionism, A Month in the Country, and The Clean House The audience breakdown varies from one production to another based on the particular play, including such factors as play name recognition, subject matter and content, whether the play is a new script or a classic, and whether the playwright is well known The attendance for the six productions was about 8,200 Ticket categories include general admission, seniors age 62 and older, and greatly reduced prices for youths under age 18 as well as students age 18 and older with proof of current school registration The productions include students in acting roles as well as in technician assignments Having students involved in productions helps RVP to accomplish its mission to provide an open, collaborative environment in which to learn and develop theater crafts

"The second largest activity is RVP's RAW Festival (RAW = Ross Alternative Works) Until 2009, RVP had staged readings of new plays by San Francisco Bay Area playwrights who have written a play that has not yet been produced and which may still be a work in progress In July, 2009, RVP decided to improve the presentation of such new works from a staged reading to a full production with memorization of the script, stage movement, costumes, stage lighting, and sound effects The intent was to provide audiences with a more complete presentation and to provide the playwright with the opportunity to see and hear a more complete production of his or her creative work in front of live audiences and to receive their immediate feedback in talkback sessions This fiscal year there were two full productions, one in October, 2014, and the second in April, 2015 Each production had six performances The RAW Festival has developed its own enthusiastic audience which continues to grow over time Fully developed productions have been well received by both playwrights and theatergoers This confirms the popularity of their experiencing new plays on more topical subject matters We often include students in both acting roles and in technical assignments For our next fiscal year of 2015 - 2016, RVP will be including the RAW Festival in its Season Subscription package to further increase RAW's publicity and audience participation
