North County Women's Center (NCWC) Comprehensive, three-story service center includes three interconnecting programming components, each of which is responsive to the unique and complex needs of the most vulnerable of homeless sub-populations: Women and Children. These components include a 32-bed emergency shelter, 23-bed transitional housing program for disabled women and children, a 2-bed medical respite program for homeless women being discharged from inpatient care. NCWC's supportive services include housing case management, life skills training, basic financial literacy education and budgeting assistance, meals, laundry, restroom and shower facilities, onsite access to primary medical and women's health services, employment assistance, and linkages to a robust network of collaborating partners.

4b (Code) (Expenses \$ 644,684 including grants of \$) (Revenue \$ 10,119)

Multi-Service Center (MSC) & Community Meals Program Daytime resource center for homeless and low-income men, women and families. Services include housing location, placement and retention support, assistance accessing financial assistance, representative payee services, money management, respite and social activities, resource referrals, employment assistance, telephone and mail service to homeless individuals, and a weekday Community Meals Program. BFHP's Community Meal is the longest running community meal program in the City of Berkeley. This program provides nutritious meals to homeless and low-income residents every weekday afternoon. Sitdown meals are served Monday through Thursday in a welcoming, cafeteria-style dining venue; take-out brown bag dinners are provided on Fridays. A vegetarian option is always available. This meal is open to anyone in need, and does not require personal information disclosure to partake in the meal.

4c (Code) (Expenses \$ 588,205 including grants of \$) (Revenue \$ 7,879)

Men's Housing Program (MHP) Located in the Veterans Memorial Building in Downtown Berkeley, the MHP includes a 36-bed emergency shelter and a 12-bed Department of Veterans Affairs' funded transitional housing program for veterans. MHP's supportive services include housing case-management, employment counseling, financial literacy education and budgeting assistance, meals, laundry, restroom and shower facilities, and linkages to a robust network of collaborating partners for employment, primary medical and mainstream benefits services. The MHP also operates the City of Berkeley's Centralized Shelter Reservation System, which has been responsible for maintaining the lowest annual shelter vacancy rates since the BFHP began System operation.
