COMPENSATION OF THE EXECUTIVE DIRECTOR IS REVIEWED ANNUALLY BY THE EXECUTIVE MEMBERS OF THE BOARD OF DIRECTORS, WHO PROVIDE A RECOMMENDATION TO THE FULL BOARD OF DIRECTORS FOR DELIBERATION AND DECISION. AS PART OF THE ANNUAL REVIEW, THE EXECUTIVE MEMBERS CONSIDER PERFORMANCE, ATTAINMENT OF GOALS AND TARGETS, AND COMPENSATION INFORMATION OF SIMILAR ORGANIZATIONS OF SIMILAR SIZE AND GEOGRAPHIC REGION. SUBSTANTIATION OF THE DELIBERATION AND DECISION PROCESS INCLUDES A REVIEW OF THE EXECUTIVE DIRECTOR COMPLETED BY BOARD MEMBERS AND STAFF, AND MINUTES OF THE BOARD MEETINGS STATING, DISCUSSING, AND APPROVING THE DECISION.
