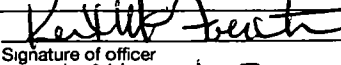

Lutheran Social Services of Alaska operates a Food Pantry at its location in Anchorage, Alaska. In FY2015 we distributed 680,231 pounds of food to 12,595 households or 30,669 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individual and religious organizations.

4b (Code:) (Expenses \$ 132054 including grants of \$) (Revenue \$ 30624)**EMERGENCY HOUSING SERVICES -**

LSSA operates two HUD housing units. The first being the Transitional Living Program (TLP) that offer housing to single homeless men. The goal of the TLP is to break the cycle of homelessness and help the residents find sustainable employment and thus sustainable housing. Clients are required to have a job in the first 30 days of residency and are required to be clean and sober. Clients are also required to participate in household chores and do volunteer work within the community. We served 18 men in FY2015.

The second is a home for women with long term behavioral health issues. This unit provides safe and affordable housing for low income individuals with long term behavioral health and medical issues. In FY2015 we served 5 full-time residents and 1 part-time resident.

4c (Code:) (Expenses \$ 120465 including grants of \$) (Revenue \$ 100)**DIRECT ASSISTANCE -**

LSSA's Direct Assistance Program covers three main areas. First is Neighbor to Neighbor, where we offer assistance to individuals who are looking for help obtaining a state ID, driver license, birth certificate, clothing vouchers, bus passes, and prescription care. Second area is with assistance with homeless prevention or housing placement though help with rental or utility assistance or paying security deposits for housing and utility hook-ups. The third area is with transportation. We provide rides to and from medical appointments, and for those who have been medivaced into Anchorage we help with transportation back to rural Alaska. In FY2015 we assisted 1,303 individuals.
