The quasi-endowment funds referenced in Parts I and V are the Sandia Excellence in Teaching Award Fund and the LVEF Endowment for the

Future. The Sandia award fund was established in hopes that it would earn sufficient interest to fund two or three \$500 awards to outstanding LVJUSD teachers each year. Unfortunately, minimal interest rates have meant the awards have been funded by a combination of principal and interest in most years. In this fiscal year, two awards were given out to teachers who had been nominated by their peers and selected by a committee assembled by the LVEF President and designated board members.

The LVEF Endowment Fund for the Future has a broader purpose to earn interest that can be used to fund LVJUSD programs and to provide seed money for LVEF fundraisers that require significant up-front expenditures.

In addition to the endowment funds described above, the LVEF accepts donations toward two scholarship funds (NSTec and David Conrad Memorial) and awards scholarships each spring/summer. Further information can be found in Schedule I and attachment pages 2 - 4.
