In the 2014-15 school year, the Berkeley High School Development Group received and processed over \$518,000 in donations and other revenue Of this total, almost \$321,000 was unrestricted for general support of the Berkeley High School learning community These unrestricted gifts funded direct student support through a variety of programs, including a school wide after school tutoring program, college and career handbooks for all juniors and seniors, fee assistance covering college application and testing fees for low-income students, writing coaches, mentors, student clubs, and forty First Step Scholarships for low-income college bound students who were the first in their families to go to college It also funded field trips, a college fair, equipment and supplies for science and art classes, professional development and training for teachers and counselors, books, classroom supplies, support for music and dance programs, and more Approximately \$197,000 was restricted to specific small schools, learning communities, and departments within Berkeley High School As a service to the Berkeley High School community, BHSDG administers these funds at no cost to the programs These funds provided student support in the form of tutors, writing coaches, and program coordinators, and also provided computers, musical instruments, college field trips, science lab supplies and equipment, and professional training for teachers BHSDG benefits from countless hours of work donated by its volunteer board and other members of the school community Thus, it was able to keep its administrative and fundraising costs extremely low, at under \$32,000 (6 5% of total costs)
