Art in Action ignites students' thinking and creativity by providing engaging visual arts programs through which they learn art history, appreciation, and skills. Our program combines a sequential K-8 art curriculum based on historically significant works of art with lesson-specific art supplies, hands-on and online training of teachers and parent volunteers, and support for schools that participate in the program. Since its inception over 33 years ago, Art in Action has delivered a powerful visual arts education to over 400,000 students and has trained over 13,000 teachers and parent volunteers to teach our dynamic curricula. As part of our mission to bring arts education to as many students as possible, Art in Action helps subsidize the program through fundraising and partnerships to keep fees affordable, especially in low-income areas and those that have little access to art education. We believe that art should be an integral part of every student's education, and that through art

The Art in Action Program is a discipline-based, Common Core aligned, visual arts curriculum where K-8 students learn creativity, problem solving and critical thinking skills, and cultural awareness. Our nine sequential program levels, based on historically significant works of art, teach art appreciation, art history, and art techniques through easy-to-present yet highly enriching content. This fiscal year we brought our program to 191 schools, representing over 1,800 classrooms and 51,000 students. Schools in 23 states are participating in the Art in Action program. Over 4,800 teachers and parent volunteers were trained to teach the program this school year. More than 1,700 boxes of pre-packaged art materials were shipped to teachers, who successfully delivered the program to their students. 3,460 volunteer hours were logged to help pack our art materials, plan our annual fundraising event, provide office support, and guide the organization as board members. A number of companies and foundations helped us expand our reach and supported the program in low-income schools through funding and in-kind support.
