Residential Treatment - providing residential services to disadvantaged, at-risk young people from throughout California. During the year covered, the program provided 49,030 days of care to 945 clients.

Nutrition Program - Boys Republic's nutrition program is part of the National School Lunch Program and School Breakfast Program which provides nutritionally balanced, free breakfast and lunch each school day to children in residential placement. During the fiscal year ended June 30, 2015, 79,382 meals were served to 916 individuals.

Family Preservation - The goal of the Family Preservation program is re-integrating youth successfully back into their home and community. In addition to full-time schooling, parenting classes, vocational and employment counseling and transportation, the program provides individual counseling to each student on at least a weekly basis, family counseling to each student's family on at least a monthly basis, and group counseling for all students on a daily basis. During the fiscal year ended June 30, 2015, 3,622 days of service were provided for 29 clients.
