The filing of Form 990 was determined by new auditor not to be necessary and the organization has been sending several letters to the IRS office in Ogden in regards to notice CP259A. Prospect One has filed Forms 990 in the past. However, these returns were filed in error as is demonstrated by the information below.

Prospect One is exempt from filing a Form 990 under the provisions of Rev. Proc. 95-48, 1995-2 C.B. 418, 1995-47 I.R.B. 13, which states that "affiliates of governmental units" are not required to file a form 990. Prospect One has the following characteristics that demonstrate that it is an affiliate of a local government:

- 1.The articles of incorporation require that Prospect One remit to the South Bay Hospital District (a predecessor entity that has been subsequently merged into the Beach Cities Health District) all of the income that is received by Prospect One. Both the South Bay Hospital District and the Beach Cities Health District are local governments that are governed by government officials elected to serve on the governing boards of these entities by the public at large. As such, all of the income and assets of Prospect One are irrevocably dedicated to the support of a local government.
- 2.The board members of Prospect One are also elected officials that serve on the board of directors of the Beach Cities Health District.
