UPON COMPLETION OF THE AUDIT, THE CPA PRESENTS A DRAFT OF THE AUDITED FINANCIAL STATEMENTS TO THE FINANCE COMMITTEE FOR REVIEW, DISCUSSION AND COMMENT. THE AUDITED FINANCIAL STATEMENTS ARE FORMALLY APPROVED AT A SCHEDULED MEETING OF THE BOARD OF TRUSTEES. THIS PROCESS HAS NOT CHANGED FROM THE PRIOR YEARS.
