Scholarships of \$1,000.00 each are awarded to qualifying high school seniors who reside in the towns served by the medical center who attend a post-secondary institution & major in a medically related field. Funds are paid after satisfactory completion of their first semester of higher education. Scholarship recipients are chosen by the high school guidance counselors at the area high schools. A scholarship of \$500.00 will be awarded to a student who is majoring in a non-medical field if their high school does not have an eligible student majoring in a medically related field.
