The Foundation's mission is to offer student teaching opportunities to college students majoring in education and to develop after-school programs. The Foundation contracts with elementary, Junior high, and high schools and others to provide teaching fellows for after-school education and tutoring. Approximately 1,200 teaching fellows helped over 18,000 students each month at school sites during the current fiscal year. The Foundation operates one major program. The program receives its revenue from service fees and conducts its own programs at the school sites and contracts with other service providers to provide program content and administration. The Foundation is supported primarily by fees for services and grants and contributions. The Foundation's program is primarily conducted in (but is not limited to) Fresno, Madera, and Merced Counties.
