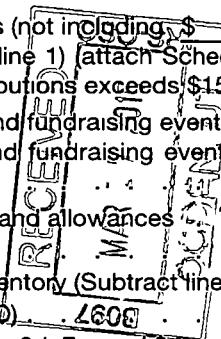

VE Global recruits, selects and trains a corps of 20-30 volunteers and interns every year from around the world to support its mission and vision. VE Global volunteers provide support to VE Global Chile and its local partner organizations in Santiago, Chile. Volunteers and the VE Global Chile team create and implement a series of innovative educational and recreational interventions and other programming for children and youth living at social risk. VE Global Chile's partner organizations include local children's shelters, a community center, and a school for children with special needs

VE Global Chile implements 5 main projects with its team of volunteers and interns in Santiago, Chile:

- 1) Vamos a Leer: a summer motivational and educational reading program;
- 2) Liga de Deportes: a monthly health and wellness sports league;
- 3) Festival de Arte: biannual art and performance exhibitions with a series of art workshops prior to the performance event;
- 4) English in Motion: dynamic English language workshops throughout the academic year;
- 5) Original Volunteer Workshops: Volunteers plan and execute a variety of creative, innovative educational and recreational workshops with children and youth in order to support their social-emotional learning and skill building.

VE Global volunteers work full-time in Chile for a minimum volunteer commitment of four months, successfully ensuring their integration into local VE Global Chile partner organizations as much-needed human resources to support children and youth in the child welfare system.

VE Global volunteers are required to commit to a minimum four-month commitment to ensure that the volunteers and the VE Global program have a positive effect in the lives of the children and youth served by its programming.

VE Global provides grant funding to VE Global Chile to support the selection, training, and ongoing in-country support of international volunteers in Santiago, Chile. Selected volunteers commit to a minimum four-month, full-time volunteer work experience. VE Global Chile provides roughly 30,000-35,000 hours of support every year to its local partner organizations through its donated, volunteer labor. VE Global Chile currently partners with 3 residential group homes that provide child welfare services to children and youth that have been removed from their families by the Chilean family court system. In addition to these residential group homes, VE Global Chile also partners with a school for children with special needs and a community center, both located in socially-vulnerable neighborhoods of Santiago, Chile.

VE Global Chile had a successful year, supporting more than 250 children in direct educational and recreational programming in its local network of Chilean partner organizations. Volunteers and interns were trained throughout the year, including in VE Global's signature initial Orientation program held in January, May and September of every year for its new, incoming volunteers. Volunteers went on to successfully implement VE Global Chile's five educational and recreational programs over the course of the year, fulfilling VE Global's mission of fostering the social-emotional development of children and youth at social risk through its strong corps of volunteers that serve as positive role models, educators, and advocates of social justice.
