Emanuel Community Center runs an urban squash program that will serve approximately 50 students The mission of this program is to change the trajectory of disadvantaged youth residing in the Over-The-Rhine community by helping them reach their full academic and athletic potential Urban squash is a nationally tested youth development program overseen by the National Urban Squash Association The program combines academics, mentoring, fitness, community service, cultural enrichment, and college placement for students in the Over-The-Rhine community It is an intensive year round programing that takes place after school, on the weekends, and in the summer and engages students from the time they join in elementary school or middle school until the graduate from college Urban squash and its education programs strive to have a transformative impact on the lives of its participants This year we completed our first school year Cincinnati Squash Academy goes through an extended tryout period before a student becomes a full member (achieve gold status) This tryout period goes on for several months where attendance, attitude and commitment are measured We had 32 students achieve gold status this year Each student received over approximately 100 hours each of academic tutoring and enrichment and squash training In addition, the students are exposed to cultural and community enrichment (local arts, service, and law enforcement engagement)
