The Covert Resort Association (CRA) operates as a Michigan Resort Association located in Covert Township Michigan. CRA provides water to 47 residences and maintains the roads and walkways. CRA does employ a caretaker who is responsible for all these duties and, in addition provides general oversight over the Association property. In addition, CRA collects the property tax from the members and remits payment to the township.

+ A LOT HOLD GAS

The Board of Directors consists of seven members who serve no more than two three-year terms. Each board member is a home-owner. The Secretary and Treasurer may be but are not necessarily board members. They are elected by the board members each year at the time of the annual meeting. The officers and the board members receive no compensation for their services.

The Board receives financial statements prior to each meeting and approves the reports submitted. Dues are collected when the winter tax bills are collected. The amount of dues is approved by the Board based on estimates of operating costs for the coming year. The amount of dues per cottage unit has been relatively constant in recent years.

Outside contractors are used on occasion for such things as water supply maintenance, tree trimming and removal, and in a few instances for road maintenance.
