Part I Line 2	Clients needing Thrift Shop social service assistance are vetted by their social workers, who in turn are employed by social service agencies which the Thrift Shop has carefully investigated before accepting them as authorized Thrift Shop agencies. Social workers vouch for the legitimacy of clients' needs and are the individuals who contact the Thrift Shop. Checks issued on behalf of social service clients by the Thrift Shop Treasurer are payable only to third parties, such as landlords, utility companies, auto repair shops, etc. A person identified as an individual landlord is checked against tax records to ensure that he or she is the actual owner of the property. In addition, Thrift Shop representatives routinely call utility companies, auto repair shops, and apartment complexes to ensure that the amounts quoted by social workers for repairs, security deposits, past-due payments, etc. are correct and that the social service clients are known to the business owners. Some special grants are made directly to a small number of social service agencies through a competitive grant application process, and these are monitored by having representatives of the agencies attend meetings of the Thrift Shop membership to report on how funds were used. Additionally, monthly block grants are made to a few specially selected social service agencies, such as Delonis Center and Safe House. These grants are designated for small items such as bus passes, birth certificates, and other kinds of documentation and were instituted by the Thrift Shop as a replacement for the countless individual requests that the agencies used to make for these items. All of the agencies receiving these grants send us monthly reports on how the money was used, and we would be happy to make these reports available to anyone interested. The agencies involved can still request larger amounts of assistance for individual clients, but the repetitive telephone requests for amounts under 50.00, the volumes of paperwork, and the cost of issuing dozens of small checks has been eliminated. It should be noted that the agencies receiving these block grants represent some of the Thrift Shops' longest-term and most highly-regarded relationships.
