The Organization's programs are as follows Musical Theater Productions Theater Latte Da produced four mainstage productions that were inspired by the richness of the human spirit with emphasis on both music and storytelling The performances resonated with people on many level as they were personal, intellectual, emotional, and visceral The season opened with a riveting play with music exploring the life and legacy of an opera diva It closed with the critically acclaimed and well-attended production of Stephen Sondheim's award winning musical Into the Woods The theater also received awards for overall excellence and best director, among others, during the season Over 30,000 people attended Theater Latte Da productions New Work Development Three teams of creative artists were given the opportunity to develop their new work over a two week period culminating in three public readings for each piece The public readings provided direct feedback to the artists which was incorporated into their next reading Once piece was chosen for the NAMT new works festival and one piece will be premiered in Theater Latte Da's upcoming season
