Hope for Haiti also gathers data from other nonprofits in Raleigh and other nonprofits working in Haiti. Once the comparative data has been gathered, a salary suggestion is made based on salaries of other employees at the organization and Hope for Haiti's annual budget. The board of directors must approve the salary decision of each employee. Salaries are reviewed on an annual basis.
