The organization accepts requests and there are no preselected charitable organizations. The primary purpose of the organization is to promote the legacy of President Andrew Johnson, who was the great-great grandfather of the donor.

We have completed a book on the life of the President. We worked with Dr. Robert Orr who is well versed on this subject. We commissioned him to do this book for a specific purpose. The original commission was for him to do the “true story of the President.” This book is about 80 pages plus photos, will be a hardback edition and will be presented to all students in the Greeneville and Greene County schools. We expect to cover from the 7th or 8th grade thru high school this year and each year in the future will go back to the school and give each student in that grade a copy of the book. Other than a few transfers in and out, this will provide a copy to future students. We believe this is an important part of the heritage of the local children. We have had very good cooperation from the U. S. Park Service and other agencies who have an interest in President Johnson.

Past projects have been acquisition of various pieces of memorabilia of the Johnson family for the National Park Service, the Presidential Library at Tusculum College and other interested public agencies.

Since Greeneville is the home of Andrew Johnson we are blessed to have the Tailor Shop, his home, his grave, and other sites maintained by the National Park Service. The corporation has assisted in providing a statue of the President and a replica of his birthplace. The Park Service opens and closes it for visitors. The corporation provides maintenance and general upkeep on an ongoing basis.

We have provided rare books relating to the President and/or his family to the Greeneville/Greene County Library and assisted the library in the renovation of acquired property for their genealogy section that houses their collection of Johnson items. They have many items from the Johnson era that are available for viewing and/or use by the public and historians.

We have also acquired three impeachment tickets for the National Park Service.

We continue to assist in the acquisition of Johnson memorabilia for the library and for the Park Service. We participate in the local “August 8” Day Celebration.

The Bartlett home was left to the local chapter of the Daughters of the American Revolution for use in their tax exempt function. We maintain the home and pay expenses such as utilities, insurance, and repairs.
