RESCUED DOGS ARE PLACED INTO TEMPORARY FOSTER HOMES WHERE THEY ARE SOCIALIZED, SPAYED/NEUTERED, VACCINATED, AND TREATED FOR ANY MEDICAL OR BEHAVIORAL CONDITIONS PRIOR TO ADOPTION. THE ORGANIZATION THEN ACTIVELY SEEKS OUT PERMANENT QUALITY HOMES FOR THESE RESCUED DOGS THROUGH VOLUNTEER NETWORKS, ONLINE ADOPTION PAGES, WEEKEND ADOPTION FAIRS, AND NEIGHBORHOOD POSTER CAMPAIGNS.
