	INPATIENT The Farnum Center's Inpatient Program is a 30-day substance abuse treatment program with the capacity to serve 40 adults with primary substance abuse issues or co-occurring mental health and substance use problems Treatment is gender specific This program is for clients who require the structure and intensive support of an inpatient setting INTENSIVE OUTPATIENT PROGRAM The Intensive Outpatient Program (IOP) program enables adult clients who do not require an inpatient level of care the opportunity to receive intensive treatment services while fulfilling their daily responsibilities such as parenting, working, or pursuing educational goals In the first phase of treatment, clients participate in programming three days a week for three hours each day over six weeks Phase two requires weekly group and individual counseling for ten weeks The program consists of group psycho-education, group therapy, individual counseling, aftercare planning and case management OUTPATIENT SERVICES Outpatient Services are available to clients who are transitioning from a higher level of care or those who need brief services for a specific purpose such as license restoration, court-ordered LADC evaluations or the resolution of personal issues Outpatient Services consist of individual counseling, group therapy, and or psycho-education classes Anger Management, Women's Group and Men's Group are examples of specialized group services SUBOXONE (BUPRENORPHINE) CLINIC The Farnum Center offers medically supervised outpatient services for opiate addicted clients Clinic participants are required to meet regularly with a Medical Doctor who specializes in addiction medicine and is specifically trained in the use of Suboxone Participation in individual counseling is a required program component MEDICAL DETOXIFICATION The Farnum Center's Medically Supervised Detoxification Program is a short term program with the capacity to serve 20 adults with primary substance abuse issues or co-occurring mental health and substance use problems, who are engaging in active substance use or who are experiencing acute withdrawal This program is for clients who require the structure and intensive inpatient medical support WEBSTER PLACE Webster Place is a comfortable, dignified, and serene recovery community located just 88 miles north of Boston The facility is situated on the private, rural home of former statesman Daniel Webster The recovery center can accommodate up to 40 residents in a 34,000 square foot complex The center is surrounded by fields, trails, and beautiful country scenery, and the property borders the Merrimack River The semi-private accommodations are well appointed, and every room has its own bathroom The furniture is eclectic, casual, and comfortable Community spaces, meeting rooms, and gathering areas are welcoming and relaxing Common areas allow residents to write, share, or just relax We respect each other's individuality and privacy and encourage some quiet time during the day to reflect, journal, and read The recreational area is geared towards exercise, music, karate, yoga, and more We take time to walk on our property, play volleyball, and use our rope swing at the river Our river side picnics are just one of the ways we enjoy sobriety at Webster Place Field trips to museums, outside meetings, and recovery events are always fun Our program enhancements include acupuncture, knitting, gourmet cooking, music, meditation, writing, arts, crafts, and exercise Our meals are always plentiful and delicious There are always wonderful aromas coming from our kitchen throughout the day Family style dining gives us time to get to know each other and share our experience, strength, and hope The real reason that folks come to Webster Place, however, is to find a way to recover from addiction to alcohol and drugs Our days are filled with lectures, meetings, group discussions, positive seminars, and special presentations Our goal is to stay sober and help someone else achieve sobriety We invite you to get sober with us
