**1** Briefly describe the organization's mission or most significant activities  
 Established as a grassroots organization in 1973 by a committed group of community activists, business owners, educators, and artists, Danforth Art is a nonprofit and privately supported museum and studio art school that invites its public to see, learn about, create, and be inspired by art. Danforth Art educates residents of Framingham and the Metrowest region of Massachusetts through its Permanent Collection of American art from the 19th century to the present day, changing exhibitions of contemporary artists, studio art classes and workshops, and a variety of community outreach programs. Danforth Art's collection includes important holdings of the School of Boston Expressionism and the work of 19th century African-American sculptor Meta Vaux Warrick Fuller. Under the leadership of Executive Director Debra Petke, Danforth Art plans to better showcase its exceptional Permanent Collection, to further refine its quality studio art classes with a focus on foundational skills, and increas

The Danforth Museum is dedicated to the celebration and creation of art. Established in 1973, the Museum is a non-profit privately supported public art museum. Its principal purpose is to further the appreciation and understanding of art and culture by providing education in the visual arts through its vast collection of American art, exhibitions, the Museum School and outreach programs in the surrounding community.

Art School - Danforth Art School offers nearly 400 studios art classes and workshops annually in a variety of media. Classes range from workshops and short classes that provide opportunities to explore or experiment with art-making to semester long opportunities that encourage the development and refinement of skills and techniques. Classes are offered at all levels from beginner to advanced, for all ages from preschoolers through adults, and in a variety of traditional media- drawing, painting, ceramics, printmaking, and sculpture- to modern media. The Art School also offers Professional Development Workshops for teachers with credit available through Framingham State University. Many of the faculty are practicing artists and have advanced degrees. The Studio Art School, which shares the current facility with the Museum, encourages teachers and students to use the museum galleries and exhibitions for study, looking and inspiration. Need-based financial aid is offered.

Membership services - Through its membership program, Danforth Art offers members and other visitors the opportunity to enhance their museum experience by taking advantage of artists talks and demonstrations, curator led discussions, and early notice of special events. Discounts are also offered to members on art classes, purchases in the gift shop, and ticketed events.

Exhibitions and collections care - Danforth Art Museum's collection consists of 3,500 works of art in a variety of media. The Collections has works from the 19th century through present day and strong holdings from the School of Boston Expressionism and a special collection of the works of Meta Vaux Warrick Fuller, an African- American sculpture and long-time Framingham resident. Danforth Art is dedicated to showing the very best examples of contemporary art by both emerging and established artists through a series of temporary exhibitions, including its celebrated Danforth Art Annual and the New England Photography Biennial. Through its exhibition program, Danforth Art Museum provides increasing interpretive and response spaces within the exhibitions offering fuller academic and aesthetic context, offer multiple entry points, and attract wider audiences.
