	Gratz College has a 121-year legacy of providing training programs for educators and communal professionals in the Jewish and secular communities. Accredited by the Middle States Commission on Higher Education since 1967, the College offers a broad array of credentials and programs, including an EdD, seven masters' programs, a BA completion program, and six graduate and undergraduate certificates. An early adopter of online education, Gratz offers blended and fully online degrees and has enrolled students from 36 states and six countries. Gratz' Jewish Community High School provides enriching and engaging programs for 8th - 12th graders in greater Philadelphia. Classes for teens are offered online through the JOLT program, drawing the participation of teens from across North America. Gratz Advance offers college credit courses and programs for high school juniors and seniors locally and in partnership with other communities. The Gratz NEXT program provides professional development opportunities for supplementary school teachers in 19 states and Canada. The institution offers four-, eight- and 12-week courses for adults as well as numerous lectures and programs throughout the year. In 2014-2015, Gratz served approximately 2,500 individuals throughout the year in its various programs.
