Learning Connections - focuses on preventing severe academic difficulties or school failure by providing intensive reading, writing and math instruction for low-income children and youth, support for their parents, and resources for classroom teachers In FY2015, the Learning Connections program enrolled 570 children, 73% of students exceeded academic growth expectations as measured on pre- and post-tests Additionally, parent engagement activities to support literacy reached 354 parents and family members, 91% of parents reported gaining useful information and strategies to support their childrens academic success
