In a town called Dajabon, that borders on Haiti & the Dominican Republic, they run a mission house, provide a special mission school for deaf children, provide many classes for adults & children to teach them English & the Bible, help homeless street children, help adults & children with healthcare, work with churches and their needs, organize & totally pay for a large Summer Camp for 140 needy and deprived children, support a Haitian orphanage consisting of 25 hungry and impoverished mouths to feed (along with providing them clothing, shoes, healthcare, improved housing, and lots of love & affection), provide medical and dental care to hundreds of adults & kids, and many other accomplishments that make a "real difference" in the lives of so many. Without the help of Touching Lives Worldwide, the deaf children would continue to grow up not knowing their own name, their age, or what colors are, or what time it is. This is because there are no opportunities for them to get an education or to know how to communicate with anyone. Without the help of Touching Lives Worldwide, the orphan kids would still be starving and very unhealthy. Without the help of Touching Lives Worldwide, there would be people that died because they did not have help to get the proper medical treatment. This organization is very small in budget, as well as volunteers, but, they do BIG things in serving God through serving others. Touching Lives Worldwide has, from the beginning, started and paid for all of its programs and projects, however, it also partners with as well as financially donates to a government certified Dominican Republic "non-profit" organization known as GOD IS TOUCHING LIVES IN D R , INC. Through this partnership, Touching Lives Worldwide can accomplish more as well as be more efficient with its funds. The end result is, there are hundreds of lives that are helped in multiple ways whether it is food, shelter, clothing, education, health & dental care, security & protection, or lots of love & affection. In addition to all the things that this organization does in Haiti and the Dominican Republic, it serves many people right here in the United States of America. Here, they are called upon to help with many needs of people of all ages. They help in more ways than the physical needs. They give advice, encouragement, and comfort during times of crisis. They provide guidance in things such as financial matters as well as spiritual ones. At times, they may just fulfill the needs of loneliness of an elderly person or they help with some other need of a person being challenged with the problems of life. In summary, they are "touching the lives" of numerous people whereby they make a "real difference" in their lives.
