College Enrichment Program

In the late Spring of 2014, Southwest Border AHEC collaborated with Southwest Texas Junior College in establishing a summer enrichment program for college students interested in entering the health professions. This was a 72 hour program designed to facilitate the entry of undergraduate students into medical and/or health care professional schools. The curriculum, which consisted of 5 enrichment courses to enhance their academic skills and competitive standing, included critical thinking, science enrichment study skills, communication skills and Chemistry Enrichment. A total of 9 community college students enrolled in the program with 100% graduating. Ten students were provided with \$100 stipend. The 4 professors each received \$750 honorarium. Other expenses included material, supplies, meals, snacks and field trips.

Del Rio Health Career Summer Camp

In response to its mission in promoting health career activities as a means of recruiting health care professionals, Southwest Border AHEC conducted a health career summer camp for the first year in Del Rio Texas which falls under one of the counties we cover. A total of ?? junior high school students enrolled in a one week summer program. Activities included hands on activities, CPR training insights from health care professionals as well as 2 field trips. Students received CPR Certification during this program. Expenses included materials, supplies, meals, snacks CPR Certification and the cost of two field trips.

Public Health Summer Camp

Southwest Border AHEC conducted for the first time a Public Health Summer Camp for High school students in Maverick County. With a total of 18 high school students the program was a success. Expenses included materials, meals, snacks, field trip as well as a graduation dinner.
