The Association's mission is to promote and grow the sport of curling in Charlotte, North Carolina and the South. Activities to achieve the mission include Learn to Curl events where the general public can come and experience the sport of curling, bonspiels which are curling tournaments that increase the visibility of the sport in Charlotte as well as North Carolina and the surrounding states, and regular league play with a variety of leagues designed to accommodate curlers of all experience and skill levels.

The Charlotte Curling Association sponsored curling leagues most every day of the week during the year ended August 31, 2015 to promote the sport of curling in the local market. The curling season began in November 2104 with the opening of the new dedicated ice facility and remained active until early May when the ice in the facility was taken down for the summer months. It is not practical to split the program service expenses between programs because the expenses are primarily for the operation of the facility which is used for all three programs. Most program service expenses have been reported under the curling leagues since they comprise the vast majority of the facility utilization.

League fees only represent the league fees paid by members who did not elect the "all you can curl" membership level. Membership dues are not included in program service revenues. This explains why the largest program has the lowest revenue.

4b (Code:) (Expenses \$ 4,581 including grants of \$ 0) (Revenue \$ 16,315)

The Charlotte Curling Association ran three curling tournaments (bonspiels) to promote the sport of curling in the local and regional market year during the year ended August 31, 2015. Two tournaments included twenty-four teams comprised of four players each. One tournament hosted sixteen teams of two each. The tournaments were three day events. As explained under 4a, most of the program service expenses have been reported under the curling leagues since the comprise the vast majority of the facility utilization. Only expenses specific to the tournaments have been reported as program expenses herein.

4c (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 34,464)

The Charlotte Curling Association conducted a number of training programs titled "Learn to Curl" where the general public could come and learn to play the sport of curling. Regularly scheduled Learn to Curl classes offered individuals the opportunity to try their hand at curling. Additionally, larger groups could schedule a group Learn to Curl class. As explained under 4a, most of the program service expenses were reported under the curling leagues which comprise the vast majority of the facility utilization.

Part II- On March 4, 2014 Douglas Young a member of the Charlotte Curling Association and a substantial contributor loaned \$200,000 to the Charlotte Curling Association as a non-interest bearing loan to be repaid in 84 equal monthly installments of \$2,380.95 commencing November 1, 2024. The loan proceeds were used as repayment of leasehold improvement funds advanced by an organization affiliated with substantial contributor David DeFehr.

During calendar 2014, an affiliate of member and substantial contributor David DeFehr constructed a building intended to serve as the long-term curling facility for the Association. The Association agreed to assume responsibility for \$650,000 of leasehold improvements relating to improvements unique to a curling facility. Mr. DeFehr's affiliate advanced funding for the improvements concurrent with building the facility. The initial loan has been reduced to its current level through donations, the loan described above from Mr. Young and the proceeds of a \$200,000 loan from a third party. The loan from the third party has been secured by a bank certificate of deposit owned by Mr. DeFehr. Interest on the \$650,000 loan is at the rate of 6% APR.

As of November 1, 2014, the Association entered into a ten-year lease agreement with Mr. DeFehr's affiliate at a monthly rental rate of \$5,500. The lease agreement includes an Association option to purchase the building at any time within the ten-year lease term. Both the Board of Directors of the Association and Mr. DeFehr believe that the lease rate, financing rate and purchase option were all executed at terms very favorable to the Association, at or below market rates for an organization without a substantial financial history.
