We as the founder of the foundation visited a senior center in Linshui, Sichuan province in China. We had discussions with seniors about their concerns and identified what they need for a better life. We worked together with their management team, assessed and set up programs that old people are highly interested, like short distance traveling and shopping, sports games and computer learning classes.</p>	0
<p>2 To promote the programs, the foundation donated funds and supplies like light sports equipment, Chinese chesses, poker cards etc. The foundation also purchased and dispatched a certain amount of food and medicines to solve the health issues important to the seniors.</p>	
<p>3 The health issues of the elderlies in nuring homes, especially the mental health issue, are always the concern of the Little Cherry Foundation. The elderlies are very eager to have a feeling of home. To satisfy their wishes, member of the foundation, Lijun Wu, visited Lijiaxiang Senior center a couple of times last year. He chatted with the elderlies, tried to understand their feelings and satisfy their needs. These activities brought them the warmth of home and gave their lives new vitalities.</p>	
<p>4 On June 20, 2015, Lijun Wu, member of the Little Cherry Foundation, visited the elementary school in Linshui city. As usual, Ms. Wu had informal discussions with the students from poor families and tried to find out their study progress and their needs. After the discussion, Ms. Wu, representing the foundation, made donations of stationaries and cash fund to the students to sponsor them through their studies.</p>
