Clinical Practice. The Family Institute (Institute) provides clinical services to clients from all walks of life. Staff therapists see clients at usual and customary charges. Revenue from the Staff Practice helps to cover the expenses of the sliding fee scale Family and Child Clinic (see Schedule O) where the average fee for service is approximately \$12.00.

Graduate and Postgraduate Education. The Institute manages two master's programs for Northwestern University, one in Marriage and Family Therapy (MFT) and one in Counseling which includes an online option. 56 students in the MFT program and 94 students in the Counseling Program, including the online component, learn applied clinical techniques to serve clients at the Institute, elsewhere in the metropolitan area and throughout the country. The Institute raises funds for scholarships for students in these programs. The Institute also provides externship training for both Clinical Psychology post-doctoral students and Psychiatric Residents from Northwestern University Medical School, and continuing professional education through conferences, lectures, seminars and clinical consultation.

Postdoctoral Fellowship Program. The Postdoctoral Fellowship Program provides advanced, intensive training for mental health professionals who have completed their Doctoral degree.
