Oppenheimer Money Market account increased from \$24500.14 to \$24503.49 for an unrealized profit of \$3.35

Oppenheimer Strategic Income account decreased from \$43290.71 to \$42782.57 for an unrealized loss of \$508.14

We have a standard brokerage account at Stofan Agazzi Investments of Joliet, IL. This account decreased from \$11027.06 to \$10322.73.

We must also account for the fact that we deposited \$7787.50 in contributions (included in line 1) and

earned income of \$126.17 from dividends and money market/sweep funds (included in line 4) but

withdrew \$7800 for scholarships (included in line 10) and there an automatic deduction of \$50 for the annual fee (included in line 10).

\$10322.73-\$11027.06 = -\$704.33

-\$704.33+\$50+\$7800-\$7787.50-\$126.17=-\$768.00 so we had an unrealized loss of \$768.00 on this investment.

Our net unrealized loss for all investments was -\$768.00-\$508.14+\$3.35 = -\$1272.79
