THIRTY ONE SUB-GRANT PROJECTS WERE COMPLETED IN THE 2014 FISCAL YEAR. FUNDS SUPPORTED TREE PLANTING ON PUBLIC LAND WHICH WERE MATCHED ADDITIONAL LOCAL FUNDS REMOVE INFESTED ASH TREES AND OTHER ACTIVITIES TO SUSTAIN URBAN FORESTS.
