Creative Writing Education The Loft offers creative writing classes year-round at Open Book, at community sites throughout Minnesota, and online In FY15, the Loft served 3,122 adults and 4,894 young creative writing students in over 460 classes and workshops and three conferences representing the broadest range of genres In the past year's evaluations, 96% of students reported that their writing improved, 98% reported a greater understanding of the writing craft, 96% agreed that the class helped them identify their next steps as a writer Poetry Out Loud - a recitation competition - offered students from 36 Minnesota schools the opportunity to participate in literary learning opportunities and advance to a national competition
