Approved and supported one new Project Transformation Chapter to launch in 2015 (Project Transformation Rio Texas), which was started under the leadership of two Project Transformation alumni. Highlights of the new Rio Texas chapter include 143 children from low-income communities served at three site church locations in San Antonio and Boerne, TX, with 100% maintaining or improving their reading level; 25 college-age young adults served as Project Transformation interns, with 95% reporting an increased desire to serve their communities after their service with Project Transformation; Over 260 volunteers from over 25 United Methodist churches served, reading one-on-one with children, providing meals to college interns, and/or donating money or supplies to the program.
