Briefly describe the organization's mission

DC SCORES changes the game for "at-risk" kids by helping them succeed in school, on the playing field, and in life. Our whole-child approach (integrating sports, arts, and service - body, mind, and soul) is unique in the DC youth development space. This school year, DC SCORES is providing free after school programs and summer camps to 2,000 children at 50 DC public and public charter schools and rec centers across the District in neighborhoods characterized by entrenched poverty. 99% of our participants are children of color, and nearly half are girls. Approximately 80% qualify for free or reduced lunch.

Elementary Program - Our holistic after-school program helps DC SCORES students improve their fitness levels by playing soccer, develop their literacy skills and capacity for self-expression by writing poetry, and establish deep community connections through service projects, all while developing closer bonds with teachers and peers. Our program follows a school-based model for after-school programming by hiring and training teachers (called our "SCORE Corps" coaches) from each school. Each school year, elementary and middle school students participate in over 24 weeks of programming. DC SCORES' elementary school program operates five days per week.

Middle School Program. The components of the middle school program build off the same structure of the elementary school programs. Middle school students become leaders in the classroom and on the field through our program.

Soccer for Success - Soccer for Success is the U.S. Soccer Foundation's free soccer-based afterschool program that uses soccer as a tool to combat childhood obesity and promote healthy lifestyles for children in under-resourced urban communities.
