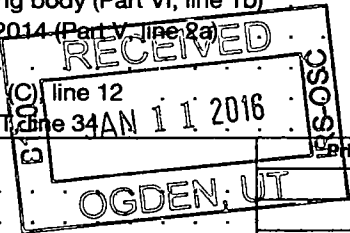

TIDE now holds 29 Virginia Swimming records.
