The Foundation's support is derived from a variety of sources, including investment income, rental income, program service fees and contributed income. No single individual or family provides a significant amount of the Foundation's support.

programs are focused on the pharmacy community, it is reasonable that the Board of the Foundation come from and are elected by Pharmacists. In addition, as pharmacists, the Board has the specialized knowledge needed to administer the programs sponsored by the Foundation. The Board members come from a geographically dispersed area around the State of Georgia and thus represent a broad cross-section of the views and interests of those served by the Foundation.

(4) The IRS Regulations contain a series of provisions not applicable to the Foundation because the Foundation is not an organization of a type that generally provides facilities or services directly for the benefit of the general public on a continuing basis, the Foundation is not an educational or research institution, and the nature of the Foundation's activities and support are different from the nature of the organizations described in these sections. However, as described in the IRS Regulations, the Foundation conducts a definitive program to accomplish its charitable work in the communities of those it serves. The Foundation programs are provided to students in the field of Pharmacy and active and retired Pharmacists in Georgia.
