PTA Comunitario - PTA Comunitario is a four-year Investing in Innovation (i3) development grant funded by the U.S. Department of Education. This project's major goal is to increase student engagement and achievement leading to high school graduation and college graduation of low-income, primarily Hispanic, LEP students from the colonias of South Texas, the most economically depressed area in the state. In service of this goal, the project has three main objectives: 1. Establish five PTA Comunitarios in each of the five South Texas public school districts with a minimum of 20 active members; 2. Establish a partnership between PTA Comunitarios and schools through training and technical assistance and 3. Facilitate the design and execution by partners of at least one educational leadership project informed by actionable data for each PTA Comunitario and partner school. A total of 31,836 students were impacted in 2015.

4b (Code:) (Expenses \$ 663,179 including grants of \$) (Revenue \$)

The development fund provides resources for mission and priority program services not supported by external funding and for development of new programs. It facilitates the dissemination of knowledge about best teaching practices in classrooms with diverse students, the creation of materials that specifically address the needs of traditionally underserved students, and research on school finance and other indicators tied to the quality of education that all students receive. On average this fund supports educational services that have a direct impact on students and teachers. Also, 852 school administrators and parents were served directly in 2015. These services have a national focus with particular interest in Texas schools and the creation of equitable educational opportunities for all children.

4c (Code:) (Expenses \$ 619,809 including grants of \$) (Revenue \$)

The Equity Assistance Center is a federally funded project that serves school districts in a five state area: Texas, New Mexico, Louisiana, Oklahoma and Arkansas. On average this project provides services to approximately 1,920 school administrators, 940 teachers and counselors, 8,660 community persons and 740 support educational personnel per year. The technical assistance and training assist schools to implement court ordered desegregation and plans and to address matters of discrimination in public education based on race, gender and national origin. Center staff work closely with Office for Civil Rights, the U.S. Department of Justice, state education agencies and other similar centers around the country to ensure that all students receive an equitable and high quality education.

CAMINOS - This project is a five year federally funded project through which IDRA has created a consortium which includes IDRA, four high-need Texas school districts and universities to certify 150 bilingual and bilingual special education teachers through an accelerated teacher preparation program. The goal of the project is to produce a rigorous accelerated and unique one and one-half year program resulting in a critical mass of highly qualified bilingual/ESL teachers or bilingual/ESL who also will become certified in special education.

The Teachers for Today and Tomorrow (T-3) is a five year project funded by the U.S. Department of Education, Transition to Teacher program. Through T-3, IDRA is selecting, recruiting and retaining competent teachers in multicultural settings who have a passion for teaching and making a difference; is developing a curriculum to certify teachers in bilingual/ESL and STEM subjects in mostly Latino communities; and is providing a comprehensive online and personalized support system to retain teachers for a minimum of three years.

T-3 also is expanding the candidate pool to include paraprofessionals, a basic feature of a "grow your own" teacher recruitment approach.

STAARS - This project is a three-year federally funded program designed to strengthen and sustain the leadership pipeline through a program of transformational professional development. Secondly, the program supports and informs a recruitment and selection strategy to select school leaders who have a disposition and skills for a turnaround campus. Thirdly, the program has as its goal to provide professional development and mentoring support to principals and turnaround team leaders. Additionally, the program supports central administration and support staff with professional development on strategies that retain effective leaders and replace ineffective leaders.

SEMILLITAS - This project responds to the need for educational equity and culturally and linguistically relevant early childhood materials for Latino, Native and African American children. SEMILLITAS will result in the implementation of an innovative and integrated approach for early childhood equity and educational transformation for vulnerable Latino, Native and African American children in New Mexico, Oklahoma and Texas through community partnerships, culturally-relevant educational materials training and technical assistance and an online community of learners. This program is funded by the W.K. Kellogg Foundation.

CCVYP - The Coca-Cola Valued youth Program funded by the Coca-Cola Foundation, provides training technical assistance, monitoring and evaluation to schools, implementing a cross-age tutoring program designed to address dropout rates. The project works with middle and high school students who tutor elementary school students.

SEED - The SEED project, funded by the W.K. Kellogg Foundation, is a program that has as its goals the strengthening of the capacity and platform for effective, coordinated family and community leadership and partnership with schools to impact policy and practice that improves early learning for vulnerable children in San Antonio, Texas.

PROGRESS - Through this grant from Marquerite Casey Foundation (Phase II), IDRA provides technical assistance to 13 organizations in the Rio Grande Valley of Texas that receive grants from the Marquerite Casey Foundation. The guidance and technical assistance provided enables these organizations to (a) develop a plan for an integrated progress monitoring system that is informed by an in-depth assessment of their current capacity and context, and (b) develops and uses an integrated system of data collection and analysis that inform and guides their work, reaching the capacity needed for sustaining impact.

ABOGAR - The Asset Building for Organizational Growth and Renewal (ABOGAR), Strengthening the Capacity of the Equal Voice Network-Rio Grande Valley program is a three year program funded by The Kresge Foundation. Through this program, IDRA is providing capacity-building training and technical assistance to nine non-profit community-based organizations (CBOs) that are providing vital human services to families and communities living in poverty in the Rio Grande Valley of Texas.

SERVICE - This program is funded by the Kresge Foundation. Through this program IDRA planned, prepared and hosted a researcher convening in San Antonio, Texas. The convening helped to bridge research and practice and highlight needs and exemplary practices across multi-service organizations and networks. A synthesis document of proceedings strengthens impact to recipients of these services.
