Programs include direct client services for persons who are already diagnosed with HIV/AIDS, HIV prevention programs, and health education and linkage programs for at-risk individuals and communities. Transportation Program provides bus passes, van rides, or taxi rides for clients to reach and maintain medical treatment, stay in care, and access other support programs. Provided 6,500 van rides, 14,000 DART bus passes, and 200 taxi rides. Daire Center, an adult day program, provided 13,000 hours of care consisting of non-medical support, stabilization, socialization, skills building activities, or respite care for high-need clients. The Nutrition Program provided 23,000 meals - breakfast and lunch are prepared and served daily for clients needing nutrition assistance to achieve better health and benefit from treatment. Linguistic Services program provides Spanish language spoken interpretation and written translation of documents for Spanish-speaking clients, their caregivers, and other service providers. Provided 7,500 units of interpretation or translation.
