 Strengthening Families Program is a drug prevention program implemented in Navarro and McLennan counties for students in 1st through 12th grades and their families where the risk of substance use and abuse are increased due to a lack of stress management and family structure In FY 2015, the Strengthening Families Program had 334 youth participants and 244 adult participants, with 93% of those completing the full 14 session program Of the participants that completed the program, 100% displayed an improvement in stress management skills, changes in their behavior and attitude regarding alcohol, tobacco, and other drugs, and a family commitment to improve the family structure

4b (Code) (Expenses \$ 557,219 including grants of \$ 4,612) (Revenue \$)
 Too Good for Drugs is a school-based drug prevention education program designed for all students in grades K-12 Students in school districts in Navarro, Kaufman, Freestone, Limestone, Hill, McLennan, Bosque, Milam, Hamilton, and Falls counties participate in the program in classroom sized groups Multiple sessions are provided to teach and reinforce social skill development that empowers students to make healthy decisions for themselves In FY 2015, the Too Good for Drugs program had 9,560 participants, with 95% of those completing the full ten session program Of the participants that completed the program, 100% displayed an increase in social skills and knowledge, as well as changes in their behavior and attitude regarding alcohol, tobacco, and other drugs

4c (Code) (Expenses \$ 392,602 including grants of \$ 3,626) (Revenue \$)
 The Project Toward No Drug Abuse program is offered at Navarro County and CISD Alternative Education Programs, as well as in McLennan, Bosque, and Falls counties, and is implemented in small group sessions Although this program is a drug prevention program, the participants have already experienced some problems that are more serious than other students so a more intense program is offered A curriculum with multiple sessions is provided along with intervention counseling, case management, problem ID and referral, and follow-ups on the referrals In FY 2015, the Project Toward No Drug Abuse program was provided to 474 participants, with 97% of those completing the full twelve session program Of the participants that completed the program, 100% displayed an increase in social skills and knowledge, as well as changes in their behavior and attitude regarding alcohol, tobacco and other drugs and decrease in their intentions to use substances
