Staff attends Community Based monthly meetings with Eddy County D W I, Chamber of Commerce, Carlsbad Coalition, Human Rights, 7024U Outreach Center, My Neighborhood & Guardians of the Children. ADCC works weekly with Student Action groups at Zia Intermediate School, The Artesia Recreational Center and Stucker Shock Kids (high school & MIP's). The primary focus for these groups is avoidance of Underage Drinking and Bullying. Coalition community partnership projects included Eddy County Fair, Artesia Homecoming Parade, Red Ribbon Week, National Night Out, APD Safety Fair & APD Drug Take Back Day. ADCC provides information to the public on drugs, bullying, gangs and other related crimes. They work closely with families that have loved ones that are caught up in drugs to find rehab centers and attend court hearings with them to help them understand the process

PACKS OF LOVE: Exp \$39,125 Including grants of \$1,310 Revenue \$12,300

This program endeavors to provide backpacks with non-perishable food inside to Artesia school children that are not receiving adequate food outside of the public school program. These backpacks are sent home with students, who are identified to the program by school staff, on Friday and the empty backpack is returned on Monday for the next weekend. In addition, (85) \$200 food vouchers were given to the families of the children in the program for the Christmas holidays; 75 food baskets were distributed at Thanksgiving; (11) \$100 gift cards were distributed for back-to-school clothes and basic school supplies were distributed to school counselors to provide to students on an as needed basis.

SENIOR SALUTE: Exp \$27,186 Including Grants of \$0 Revenue \$29,093

This event is an all-night lock-in that provides great food, decorations and games/activities to help high school seniors celebrate their graduation in a safe, alcohol and drug free environment. Seniors' parents collect donations from local businesses and individuals, which is used to purchase minimal supplies for decorating and activities. The bulk of the donations go to purchasing prizes, which are used as incentive to draw seniors to this event. The prizes are given out at the end of the event (6 a.m.) and anyone leaving Senior Salute forfeits all winnings. Approximately 300 high school students participated in this year's event, and gifts to the high school seniors totaled \$25,700.

RIDE FOR BIKES: Exp \$24,509 Including Grants of \$6,660 Revenue \$ 41,144

Donations are requested and one fundraising event is held each year: the Wet N Wild 4K. This fund raiser is a run featuring local fire departments with props aimed at getting participants soaking wet. This event generated net revenue of \$6,700 this year for scholarships. Ride for Bikes provided 342 bicycles at Christmas to children through Artesia kindergarten. Ride for Bikes also awarded two scholarships to area high school seniors this year. The recipients are awarded a high quality bicycle to aid with transportation on campus as well as a \$1,000 scholarship per semester for up to eight semesters.
