WORLDVIEW CENTER RESIDENTIAL PROGRAMThe WVC ministry maintained a student census of approximately 45 residents during this fiscal year Those students, studying at Western Seminary, Multnomah University, and involved in local churches in Portland, came from Nigeria, China, Taiwan, Hong Kong, South Korea, Egypt, Ecuador, and USA Because there were reduced numbers of international students in local educational institutions, we opened housing opportunities to more US-based students who are studying in local schools

IICC GENERALAt the overall organizational level, IICC continued to build on the strategic planning process begun in the fiscal 2013 and 2014 In particular, IICC has worked towards finalization of plans in two directions 1)IICC/WorldView will separate into two different organizations, each with independent legal status One organization will maintain the IICC name and history, and will focus on providing training for people involved in cross cultural ministry The other organization will provide housing and Christian community for international Christian workers who are in the Portland, Oregon area At the close of fiscal 2015, the residential ministry is still operating under IICC, but the legal and financial structure is being prepared to operate independently of IICC The new organization will be called Sanctuary Inn We anticipate separation of the Sanctuary Inn from the IICC in June or July of 2016 2)As part of this separation of program elements, the current WorldView Center building located at 6012 SE Yamhill St, Portland, OR is in contract for sale We anticipate closing the sale of the WorldView Center building in late December 2015 or early January 2016

WORLDVIEW INSTITUTE TRAINING PROGRAMThe deliberate training program of IICC provided funding for former WorldView Graduate Center MA students who have transferred to the MA program at Hope University of Fullerton CA Those transfer students completed their studies in the spring of 2015 WVI also provided nonformal training for cross cultural workers serving with ministry partner agencies based out of Kansas City, Argentina, Panama, Cuba, and Uganda WVI also initiated a new training focus in the area of second language acquisition In fiscal 2015 we ran beta testing of that language training program, with the intention of offering it widely in fiscal 2016 in both Panama and US Finally, during 2015 IICC staff taught as part of Western Seminary courses, and began to develop a non-degree program in conjunction with the Seminary

Funding sources for the above costs are received by the IICC as donations. When donation levels are insufficient, compensation may decrease, in times of surplus donations there is no increase in compensation as a direct consequence. Some senior staff members serve on loan from other organizations. Under those circumstances a Memorandum of Understanding (MOU) will set compensation packages. These MOUs will reflect seconded staff compensation that is compatible with the IICC support schedule. All such MOUs will be approved by the IICC Board of Directors. Adjustments to the support schedules are regularly considered on the basis of inflation and cost of living expenses. If an IICC staff member receives honoraria, they will be turned over to the IICC (or the sending agency in situations of secondment). |
